Privacy notice

Under data protection law, individuals have a right to be informed about how the Trust uses any personal data that Leigh Academies Trust (LAT) hold about them. We comply with this right by providing 'privacy notices' (sometimes called 'fair processing notices') to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about individuals that visit our Trust or its academies.

We, Leigh Academies Trust (LAT), are the 'data controller' for the purposes of data protection law.

Our Data Protection Officer is Stephane Vernoux (see 'Contact us' below).

The personal data we hold

We process data relating to those who visit our Trust or its academies. Personal data that we may collect, use, store and share (when appropriate) about you includes, but is not restricted to:

- Contact details(e.g. phone number, address, email address);
- Photographs;
- Car registration information;
- CCTV;

Why we use this data

The purpose of processing this data is to help us run the Trust and its academies, including to:

- Health & Safety;
- Safeguarding.

Our lawful basis for using this data

We only collect and use personal information about you when the law allows us to. Most commonly, we use it where we need to:

- Comply with a legal obligation;
- Carry out a task in the public interest;

We may also use personal information about you where:

- You have given us consent to use it in a certain way.

Where you have provided us with consent to use your data, you may withdraw this consent at any time. We will make this clear when requesting your consent, and explain how you go about withdrawing consent if you wish to do so.

Some of the reasons listed above for collecting and using personal information about you overlap, and there may be several grounds which justify the Trust's use of your data.

Collecting this information

While the majority of information we collect from you is mandatory, there is some information that you can choose whether or not to provide to us.

Whenever we seek to collect information from you, we make it clear whether you must provide this information (and if so, what the possible consequences are of not complying), or whether you have a choice.

How we store this data

We maintain an academie's visitor management system. We will retain this file and delete the information in it in accordance with the LAT Data Retention Policy.

Data sharing

We do not share information about you with any third party without your consent unless the law and our policies allow us to do so.

Where it is legally required, or necessary (and it complies with data protection law) we may share personal information about you with:

- Security organisations - to meet our legal obligations to share information where appropriate, such as safeguarding concerns;
- Health and social welfare organisations - to meet our legal obligations to protect the welfare of staff and pupils.

Transferring data internationally

Where we transfer personal data to a country or territory outside the European Economic Area, we will do so in accordance with data protection law.

Your rights:

How to access personal information we hold about you

Individuals have a right to make a 'subject access request' to gain access to personal information that LAT holds about them.

If you make a subject access request, and if we do hold information about you, we will:

- Give you a description of it;
- Tell you why we are holding and processing it, and how long we will keep it for;
- Explain where we got it from, if not from you;
- Tell you who it has been, or will be, shared with;
- Let you know whether any automated decision-making is being applied to the data, and any consequences of this;
- Give you a copy of the information in an intelligible form.

You may also have the right for your personal information to be transmitted electronically to another organisation in certain circumstances.

Your other rights regarding your data

Under data protection law, individuals have certain rights regarding how their personal data is used and kept safe. You have the right to:

- Object to the use of your personal data if it would cause, or is causing, damage or distress;
- Prevent your data being used to send direct marketing;
- Object to the use of your personal data for decisions being taken by automated means (by a computer or machine, rather than by a person);
- In certain circumstances, have inaccurate personal data corrected, deleted or destroyed, or restrict processing;
- Claim compensation for damages caused by a breach of the data protection regulations.
